- **If the appropriate NADA guide or Blue Book information is not available, the 10 yr. schedule can be used for Passenger Vehicles.**
- **Large computerized medical or industrial equipment, and large main frame computers costing more than \$100,000 should use the 8 yr. schedule. This type of equipment costing less than \$100,000 should use a 9-yr schedule.**
- **Non-computerized industrial eq., forklifts, pallet trucks, carwash eq. & construction eq. should use the 12-yr schedule.**
- **Gasoline tanks & piping should use the 20-yr schedule.**
- **Sign poles & billboards should use the 30-yr schedule. See Appendix L-4 of the Field Appraisers Guide.**
